

Privacy Policy

The protection of your personal data is taken very seriously. We treat your personal data confidential and to the accordance with the provisions of the general data protection regulations (GDPR, Dsg TKG 2003). In this data protection information, we want to inform you about the most important aspects of data being processed within the framework of our website.

Contact us

In the case of establishing contact with us via our website or by e-mail, we shall save your details to reply to your questions(s). Such data are saved solely for the purpose of replying to your enquiry.

Purpose of Processing / Legal basis

We will only use the personal data you provide to the extent necessary to fulfil the relevant purpose; Such as.

- contractual obligations
- legal obligations
- IT security and IT operations
- job application data
- promotion
- asked Information

The criteria used to determine the period of storage of personal data is the respective statutory retention period. After expiration of that period, the corresponding data is routinely deleted, as long as it is no longer necessary for the fulfillment of the contract or the initiation of a contract.

Disclosure of personal data:

Categories of recipients of the personal data

- public authorities and agencies
- public bodies and institutions
- IT service provider
- banks / insurances
- software manufacturer
- service provider

In all other cases, data is not passed on without the explicit consent.

Forwarding data to third parties

As a rule, our external service providers process your personal data within the European Union (EU) or the Contracting States to the Agreement on the European Economic Area (EEA). If your personal data is transmitted to and processed by a service provider based in a third country, the processor is obliged to guarantee that your data is protected at all times with the conclusion of standard data protection clauses or the EU-US Privacy Shield.

Personal data are only forwarded to bodies | countries outside the European Union (so-called third countries) where this is required to perform your orders, where such action is specified by law or if you have granted us your consent in that respect.

Storage

To Purpose of the contract processing be the following data also stored with us: *Address data, bank details, contact details, business incident data*. The data you provide is available for the fulfillment of the contract or required to implement pre-contractual measures. Without this data, we will not be able to conclude the contract with you. Data is not transmitted to third parties, with the exception of the transfer of credit card data to the processing bank institution/payment service providers for the purpose of debiting the purchase price, to the transport company contracted by us. Shipping company for the delivery of the goods as well as to our tax advisor to fulfill our tax obligations.

After cancelling requests or contracts, data stored with us is deleted. In the event of a conclusion of the contract, all data from the contractual relationship will be stored until the expiry of the tax retention period (7 years). The dates name, address, purchased goods and date of purchase are also stored until the end of the product liability (10 years). Data processing is carried out on the basis of the statutory provisions of § 96 (3) TKG and Art 6 (1) Lit a (consent) and/or Lit b (necessary for the fulfillment of the contract) of the GDPR.

Once the purpose for storage no longer exists, or the applicable statutory period has expired, the personal data will be routinely blocked or erased in accordance with the statutory regulations. The storage duration criterion is the relevant statutory retention period.

Web analysis
